#### **IPM statement**

It is the goal of <u>Pope Valley Elementary</u> to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: (Example: Focus on long-term pest prevention)

Seal our facilities and prevent intrusion and migration into our buildings. Prevent any vegetation pathways into our buildings and structures. Maintain a clean environment and deprive pest of any dwelling or consumption material. Identify all pests around our property grounds and catalog for further research of preventative measures.
